Instructions on how to apply for the exam are outlined below.

TESTING CLASSIFICATIONS AND SALARY INFORMATION (as of 7/1/15):

CUSTODIAN (CF) Monthly Salary Range: \$2194-\$2745

LEAD CUSTODIAN (CF) Monthly Salary Range: \$2354-\$2947

CUSTODIAN SUPERVISOR II (CF) Monthly Salary Range: \$2621-\$3285

CUSTODIAN SUPERVISOR III (CF) Monthly Salary Range: \$2837-\$3553

MINIMUM QUALIFICATIONS:

CUSTODIAN (CF): <u>Either I:</u> 6 months experience in CA State service performing the duties of a Service Assistant (Custodian) <u>Or II</u>: 6 months experience as a Custodian.

LEAD CUSTODIAN (CF): <u>Either I:</u> 1 year experience in CA State service performing the duties of a Custodian (CF) or Custodian. <u>Or II:</u> 2 years experience in janitorial work (1 year of this experience must be in a supervisory capacity over other employees and responsibility for janitorial work in an office or similar building) <u>AND</u> education equivalent to completion of the 8th grade.

CUSTODIAN SUPERVISOR II (CF) <u>Either I</u>: 1 year experience in CA State service performing the duties of a Lead Custodian (CF) or Lead Custodian <u>or</u> 2 years experience in CA State service performing the duties of a Custodian (CF) or Custodian. **OR II**: 3 years experience in janitorial work (2 years of this experience must be in a supervisory capacity over other employees with responsibility for janitorial work in an office or similar building) <u>AND</u> education equivalent to completion of the 8th grade. (Additional qualifying experience may be substituted for the required education on a year-for-year basis.)

CUSTODIAN SUPERVISOR III (CF) <u>Either I</u>: 2 years experience in CA State service performing the duties of a Custodian Supervisor II or Custodian Supervisor II (CF). <u>Or II</u>: 4 years experience in janitorial work (3 years of this experience must be in a supervisory capacity over other employees and with responsibility for the janitorial work in a large building or group of small buildings) <u>AND</u> education equivalent to completion of the 8th grade. (Additional qualifying experience may be substituted for the required education on a year-for-year basis.)

If you meet the minimum qualifications for one or more of the above classifications, please proceed to the application process.

HOW TO APPLY FOR THE EXAM:

1. Go to http://www.cphcs.ca.gov/hodes/index.aspx

2. Under column "Bulletin Title" search for the desired custodian classification

3. Under column "Take Assessment" select "Complete Self-Assessment"

4. Follow "Login" instructions

5. Take exam

<u>Please Note</u>: If applying for more than one of the above custodian classification exams, you must repeat the application process for each classification by logging back in with your login information.

<u>APPLICATION DEADLINE/TESTING PERIOD</u>: Applications will be accepted on a continuous basis. The testing period for this exam is 6 months. Once you have taken the exam you may not retest for 6 months.
